# Form 2A | Registration Statement for Foreign General Partnership

**General Statement.** Partnerships are governed by Chapter 20, Sections 2001-2014, of Title 12 of the Palau National Code. Any partnership formed under the laws of another jurisdiction that is doing business in Palau must provide the following information and file this Registration Statement with the Office of the Registrar. <u>The form must be submitted within 30 days</u> <u>of commencement of business</u>. Submit the form to: Financial Institutions Commission, Surangel & Sons Building, 2<sup>nd</sup> Floor, Ernguul Road, Ikelau, Koror, Palau. This form must be accompanied by a filing fee of \$250.00. If you are paying by check, it must be payable to the Palau National Treasury.

**Instructions for this form.** You must use this form to register your foreign general partnership. All information must be provided in English and should be typed or printed in legible BLOCK LETTERS. If there is insufficient space on the form to supply the information required, attach a separate sheet containing the information.

**Notarization.** This form must be acknowledged by each partner before a notary public or other officer in the manner provided by law for acknowledgment in the jurisdiction in which each partner is signing.

Note: the partnership name may not be identical or almost identical to the name of another active local or foreign partnership, corporation, or any other registered business entity. The partnership name may not mislead the public about the nature of the partnership's business in Palau and must not be deceptive or offensive. You may provide an alternative partnership name.
