There is no fee for filing if filed in a timely manner.

All information must be provided in English and should be typed or printed in legible BLOCK LETTERS. If there is insufficient space on the form to supply the information required, attach a separate sheet containing the information.

**Notarization.** This form must be acknowledged by each partner before a notary public or other officer in the manner provided by law for acknowledgment of deeds. However, if a partner that has withdrawn cannot be located, or if a partner is deceased, then this statement can be signed by the remaining partners.
