The form must be submitted on or before June 30 of each year, as of December 31 of the preceding year. Submit the form to: Financial Institutions Commission, Surangel & Sons Building, 2nd Floor, Ernguul Road, Ikelau, Koror, Palau. This form must be accompanied by filing fee of \$50.00. A late filing fee will accrue of \$50.00 per month for each month that it is late up to a maximum penalty fee of \$250.00. If you are paying by check, it must be payable to the Palau National Treasury.

Instructions for this form. You must use this form to file the annual statement for your foreign general partnership. All information must be provided in English and should be typed or printed in legible BLOCK LETTERS. If there is insufficient space on the form to supply the information required, attach a separate sheet containing the information.
