**General Statement.** Partnerships are governed by Chapter 20, Sections 2001-2014, of Title 12 of the Palau National Code. Section 2007 requires any partnership that dissolves to file a statement indicating the reason for dissolution. <u>The form must</u> <u>be submitted within 30 days of the date of dissolution</u>. Submit this form to: Financial Institutions Commission, Surangel & Sons Building, 2<sup>nd</sup> Floor, Ernguul Road, Ikelau, Koror, Palau. There is no fee to file this form.

**Statement particular to limited partnerships**. Limited Partnerships are also governed by Chapter 20, Sections 2021-2048 of Title 12 of the Palau National Code. Sections 2044-2045 provide that a limited partnership may file a Cancellation which terminates the limited partnership. There may be occasions where a limited partnership may first file a dissolution before cancelling its certificate. See Section 2043 for further details.

Court order. A court may order the cancellation of a limited partnership. See Section 2045(d).

**Instructions for this form.** You must use this form to dissolve your partnership. All information must be provided in English and should be typed or printed in legible BLOCK LETTERS. If there is insufficient space on the form to supply the information required, attach a separate sheet containing the information.
