

BOEX **IS NOT** A REGISTERED ENTITY AUTHORIZED TO
OPERATE IN THE REPUBLIC OF PALAU
Koror, Republic of Palau – September 8, 2025

The Republic of Palau Bureau of Revenue and Taxation, where business licenses are issued; the Foreign Investment Board; the Office of the Corporate Registrar; the Digital Residency Office; and the Financial Intelligence Unit (“FIU”) are jointly issuing this press release to notify the public that **BOEX is not registered** in the Republic of Palau and **is not authorized** to engage in any business activities within the Republic of Palau. **BOEX is not** affiliated with the Palau Residency Program or the Palau Stablecoin Project. The agencies caution the public against engaging with **BOEX**.

As reported by Followin.io in Chinese, BOEX, a blockchain consortium, purports to have launched its platform and regional operations in Palau in July 2025, with an in-person event in August 2025, using a new model based on tokenized resource governance and digital finance infrastructure. **However, BOEX has not registered with or received authorization to operate by any agency in Palau and is, as a result, not in compliance with Republic of Palau laws.**

The Palau Bureau of Revenue and Taxation; the Foreign Investment Board; the Office of the Corporate Registrar; the Digital Residency Office; and the FIU ask that the public exercises caution when engaging with BOEX at this time, and until their registration status changes.

Furthermore, natural or legal person that engage in the exchange or transfer of virtual asset as a business activity will be subject to FIU (palaufiu.org) supervision.

BOEX並非註冊於帛琉共和國的合法營運實體

帛琉共和國稅務局(負責發放營業執照)、外人投資委員會、公司登記處、數位居留辦公室，以及金融情報單位共同發布此新聞稿，正式通知社會大眾，**BOEX並未在帛琉共和國註冊，也未獲授權於帛琉境內從事任何商業活動**。BOEX與帛琉數位居留計畫或帛琉穩定幣計畫**並無任何關聯**。上述機關提醒大眾，務請提高警覺，避免與BOEX往來。

根據Followin.io以中文發布的報導，BOEX自稱為區塊鏈聯盟，宣稱已於2025年7月在帛琉啟動其平台與區域業務，並於同年8月舉辦實體活動，聲稱採用一種基於代幣化資源治理及數位金融基礎設施的新模式。**然BOEX從未在帛琉任何主管機關完成註冊或取得營運許可，因此未符合帛琉相關法規。**

帛琉稅務局、外人投資委員會、公司登記處、數位居留辦公室及金融情報單位提醒大眾，在BOEX註冊狀態改變前，應審慎評估並避免與其進行任何往來。
